GSO Special Situations Fund Ltd. held a total of \$45,710,491 in Allowed Unsecured Claims, GSO Special Situations Overseas Master Fund Ltd. held a total of \$42,564,465 in Allowed Unsecured Claims, GSO Palmetto Opportunistic Investment Partners LP held a total of \$14,070,050 in Allowed Unsecured Claims and GSO Credit-A Partners LP held a total of \$17,654,994 in Allowed Unsecured Claims.
